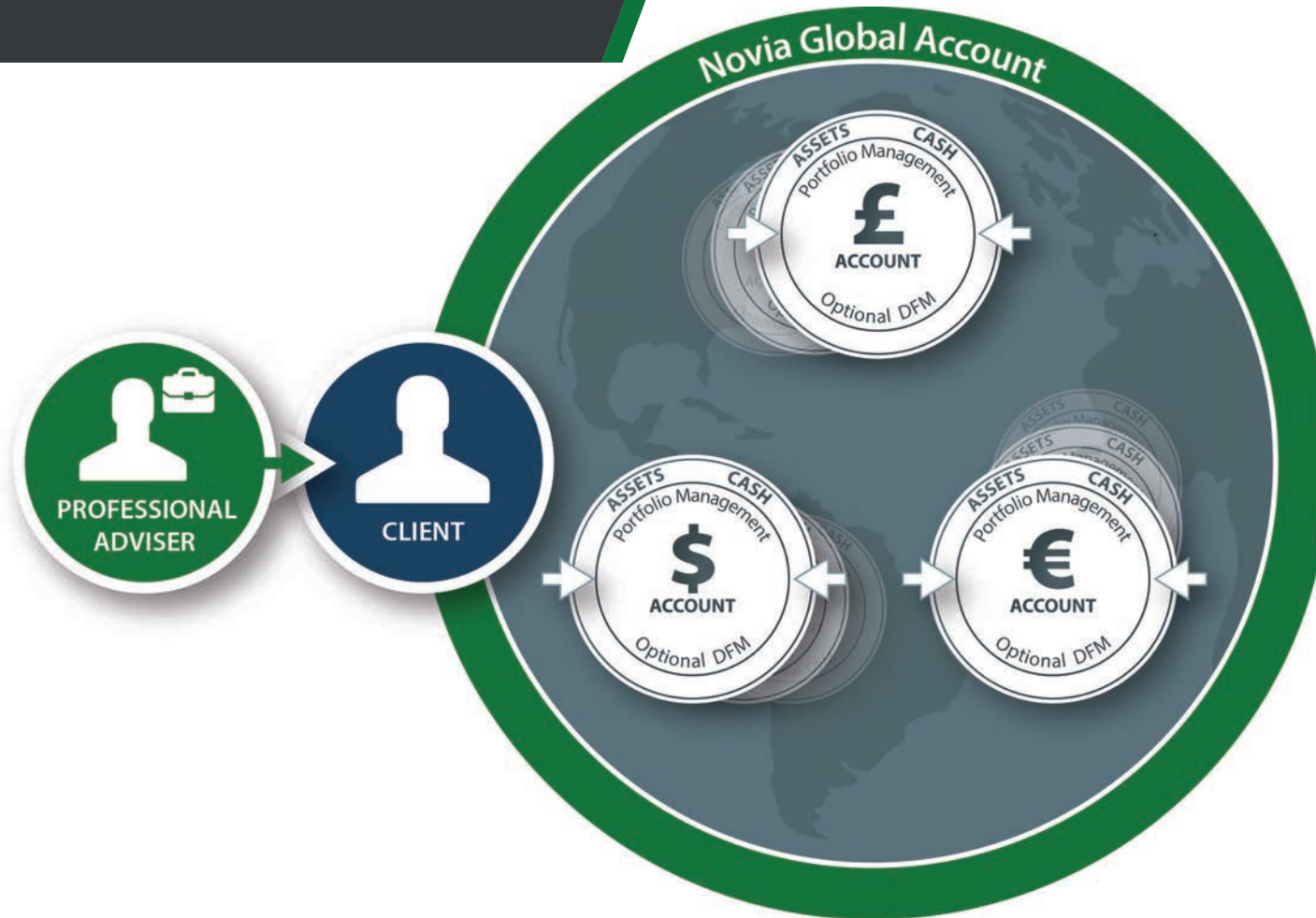
Security – ensuring that your assets are managed safely and securely is always at the heart of our proposition.

We also constantly review and test our processes and procedures to ensure we pursue the best practices in client money and asset protection.

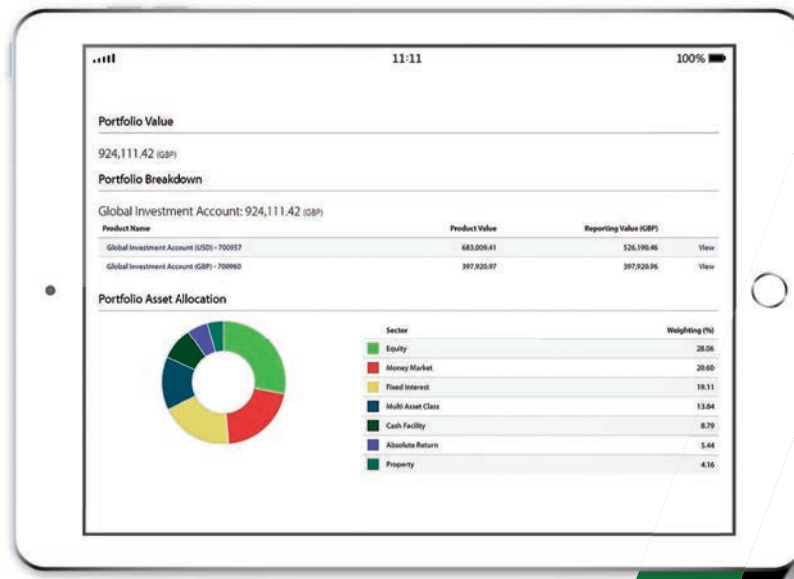
