## Signature Requirements

Electronic signatures must:

- ◆ Be applied using recognised e-signature software (e.g. Adobe, DocuSign)
- ◆ Include a certificate of validation
- ◆ Use an email address matching the adviser's registered company email or the client's registered Novia Global email
